Entry Guidelines

Parade Date: Saturday, December 2, 2023 at 4:00 pm

Entrance Fee: Nonperishable Food

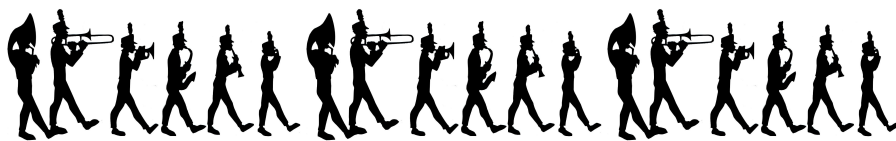
1. **GENERAL:** Parade Application and Waiver Forms **must be** completed and faxed or mailed to the address shown by November 27, 2023. No entry will be allowed without an application and signed waiver due to NC law. Any late entry will be placed at the back of the line.
2. Any **MUSIC** played must pertain to Christmas.
3. All entries should have a sign that shows the group or organization they represent.
4. **CLOWNS:** Names of all **CLOWNS** must be included on the application as participants.
5. **CARS:** All car doors must remain closed while in movement.
6. All **HORSES** must be groomed for show and riders must be in appropriate dress. A parent, guardian, or responsible adult must accompany any rider under the age of 16. All equestrian individuals or groups are responsible for providing their own "pooper scooper."
7. **CARS, GOLF CARTS, MOTORCYCLES, and FLOATS:** All must have a sign or banner on each side to identify your group or business. Golf carts that are part of the "Golf Cart Brigade" must be decorated in order to be judged.
8. **FLOATS:** Tractors can be used to pull floats or can be an entry. Pick-up trucks can also be used to pull a float or it can be an entry if it is appropriately decorated.
9. **CHECK-IN** by 3:00 pm at the Grifton FWB Church at 674 Wall Street, with **Patricia Riggs**.
10. The Parade Officials receive the right to deny entrance to the parade for:
 - a. Late Arrivals.
 - b. Entries that do not comply with the guidelines.
 - c. Entries deemed inappropriate or unsafe.
